The MedicAlert Foundation first launched in Turlock, California, in 1956, before coming to the UK over 55 years ago. As the pioneers of medical IDs, we remain the only charity provider of life-saving medical ID services worldwide.

MedicAlert UK is based in Buckinghamshire, with a production unit creating bespoke medical ID jewellery and a member services team including in-house Registered Nurses to support our members.

The MedicAlert Foundation has grown internationally, with nine locations as far spread as South Africa and Malaysia, to locations such as Iceland and Cyprus.

MedicAlert UK supports individuals by keeping them safe in an emergency and providing them with peace of mind. Today, MedicAlert UK are working hard to continue to:

- Build strong partnerships with charities that support people with numerous health conditions.
- Maintain an education service for all emergency services and healthcare professionals.
- Drive awareness amongst the public, ensuring everyone understands the importance of checking for MedicAlert ID jewellery.
- Work with corporate partners to grow our membership and provide safety and peace of mind to more people to improve lives.

# Why is MedicAlert's service so vital?

1 in 4 people in the UK live with a medical condition that causes them to feel vulnerable in their daily lives; this affects the individual, their friends, family, and loved ones.

MedicAlert IDs, worn on pulse points, can be lifesaving for anyone living with medical conditions or allergies in an emergency. The peace of mind they provide can support confidence to be more active physically and join in socially. Friends and family also benefit from knowing their loved ones are safe. With medical records accessible via our 24/7 Emergency Line. We employ Registered Nurses to check these records so that medical professionals can rely on them to quickly select the right treatment option in an emergency. What do our members tell us:

- That wearing a MedicAlert ID increases confidence that their conditions will be identified in an emergency by 128%.
- That wearing a MedicAlert ID increases confidence that the correct treatment would be given increased by 131%
- Their overall peace of mind and happiness increased by 65%.

# Ways you can work with us

## **Programme Partners**

This involves setting up and identifying groups or individuals who need support to join MedicAlert and usually results in the setting up of a MedicAlert Protection Programmes (MPP).

#### What is a MedicAlert Protection Programme?

We create MedicAlert Protection Programmes to support discrete groups who will benefit from our service but may not be able to access it without support. We work with other organisations who identify the individuals who have a requirement and organisations who can support the programme through funding, if required. medicalert.org.uk/becoming-a-partner/

# **Referral Partners**

Our referral partnerships are with organisations that can refer people to us through websites, newsletters etc. For example these could be related charities, illness related charities, specialist charities, Institutes, Government Departments (e.g. Health, education), online magazines or health and wellness apps. # **Sponsor Partners**

A really successful example of one of our sponsor projects is the Early Start Programme sponsored by Lions Club International. Our Early Start Programme protects vulnerable children living with medical conditions or allergies. Sponsored by Lions Clubs International, the programme provides free MedicAlert membership until their 10th birthday, along with a medical ID. For every 2 places that Lions Clubs International funds, we sponsor an additional place for the programme, helping to support more children around the UK with hidden medical conditions. This programme has supported over 700 vulnerable children since it started in June 2018.
